IPNA have made a submission to NMBI regarding Section 40 of the Nurses and Midwives Act which concerns the Professional Indemnity for Midwives.

This submission is based on the challenges that exists for members to maintain their skills and competency's in the absence of indemnity. Further meetings with the IPNA and Dawn Johnson Director of Midwifery are planned

- There is a massive increase in the number of GPs and Practice Nurses required, to deliver the new Primary Care Programmes and health initiatives.
- > The IPNA is working with the ICGP in developing a National Strategy for Addressing the Educational Needs of Practice Nurses in General Practice
- In order to encourage highly qualified, experienced nurses to take up these roles they will need educational opportunities and career pathways similar to those available within the HSE.

PDCs' Report by Patricia Mc Quillan; There were no motions proposed in 2018.

Election of NEC Officers: National Chairperson — Gillian Redmond, National Vice-Chairperson — Elaine Scanlan, National Honorary Treasurer — Josephine Heward, National PRO — Pauline Kilcoyne. The Mayo Branch will host Conference 2019.

Winnie Quigley National Membership secretary advised that members are not identifying if they have clinical indemnity on the national membership database which is concerning. TREASURER'S REPORT

Josephine Heward National Honorary Treasurer (IPNA Donegal Branch) gave the National Honorary Treasurer's report, as follows.

The role of National Honorary Treasurer involves:

- 1) Overseeing national and conference accounts via e-mailed updates, monthly bank statements with explanatory notes from Administrator, and directly via internet banking.
- 2) Approving any unusual day-to-day transactions and Administrator Office Expenses. Any costs which are large, unexpected or arising for the first time may be referred to the NEC for approval.
- 3) Authorise (or not) any direct payments that have been set up via internet banking by the Administrator.
- 4) Liaise with other NEC Officers whenever necessary re day-to-day management of the association and any issues that arise.
- 5) Give Honorary Treasurer's Report at AGM.

Functions delegated to the IPNA Administrator:

- 1) Maintaining records on 2 national accounts (current & conference account).
- 2) Collecting records of 18 branch accounts.
- 3) All financial transactions (lodgements, invoices in & out, expenses)
- 4) Salaries, PAYE, PRSI, USCs, Payslips, Employer's RSI.
- 5) Liaising with accountant regarding income tax liabilities and annual preparation of accounts.
- 6) Liaising with Revenue to ensure retention of charitable tax exemption and compliance with legislation.
- 7) Liaising with bank as necessary.
- 8) Preparation of draft budgets for NEC to examine and approve at February meeting, with updates at all subsequent meetings.
- 9) Preparation of final account summaries for Annual Report and AGM.

- 10) Reporting to sponsors of Awards about how their grants were spent.
- 11) Liaising with Membership Secretary and conference organisers to lodge membership fees, delegate registration fees and sponsorship payments.



ANY OTHER BUSINESS

Karen Canning and Roisin Doogue presented an update regarding Practice Nurse PGDip being developed. This is dependent on funding, and initial talks are beginning with prospective

universities. It is hoped that this will lead to practice nursing becoming recognised as a speciality and having a division on the NMBI register. Copies of the Document "Addressing educational needs of Practice Nurses in Irish General Practice" was made available for IPNA members. Open discussion ensued with regards to affordability/accessibility of the proposed programme. It was agreed that the document would be made available for IPNA members on the website and that Karen Canning and Roisin Doogue continue to collaborate on this development on behalf of the IPNA.

Rita Calally (IPNA South Dublin branch) requested the timing and format of the AGM be reviewed for future meetings to allow members have adequate time for open discussions.

Gillian thanked the Mayo Branch again for all their work in producing an excellent conference. She also acknowledged the voluntary work of the Branch Officers, Branch NEC representatives, and all who attend meetings on behalf of the IPNA. Ruth Dougan (IPNA Limerick/Nth Tipp) requested clarification in acknowledging members who retire from Practice Nursing. Caroline will circulate the IPNA guidance on financial expenditure. Caroline also mentioned to delegates that this is the 3-rd. year at the AGM where no motions have been proposed. She reminded delegates that the IPNA is owned by its members who have a voice in its role. She will circulate to all IPNA members the Articles of Association which govern the day to day functions of the association to allow members review same and suggest any changes
